MITCHELL COMMUNITY REVEALED By: Joao da Fonseca and Mike Vogel

Most Mitchell students have been out in the surrounding community, whether it's a jaunt to Billy's, Café Latte, or Axel's Bonfire. Some students even live in the nearby apartments. However, much of the community's rich history, quaint offerings, and overall concerns about property damage sometimes go unnoticed. We sat down with Bob Kaplaun, who has been living in the community since 1982. He shared his insight with us about the community and his experiences.

BOB'S TRANSPORTATION

Kaplaun uses a red tricycle to get around. His good friend Rascal is always with him. One afternoon, a couple weeks ago, Kaplaun's terrier was attacked in the neck by a much bigger dog close by William Mitchell. Kaplaun thought Rascal's days were over when he saw Rascal in the other dog's mouth. The dog owner was not able to keep the dog under control. Rascal, however, proved to be a much stronger dog and survived the attack. As usual, Rascal continues to pull Bob in his tricycle.

A SUPRPRISE HISTORICAL NOTE OF THE GRAND AVENUE SHOPPES

Kaplaun remembers an ice cream shop on Grand Avenue that contained a photo of what was in the ice cream shop's location in the 1930's and 1940's, a Ford Dealership. This isn't the only spot on Grand Avenue to see a change from a car dealership to another establishment over the years. It's hard for The Opinion to neglect reporting that one of the favorite dining locations for Mitchell students, Café Latte, was formerly Studebaker and Oldsmobile dealership until it was sold.

THE FARMER'S MARKET: A GREAT COMMUNITY OFFERING

In the late spring, summer, and into the early fall, Kaplaun recommends stopping by the farmers market for great food and fantastic values. Kaplaun tells us that between April and October, the City runs a farmer's market at the Church Parking lot on Lexington and Summit. He eats lunch there often and reports that the prices are better than what you would find at Whole Food or Mississippi Market.

THE GOVERNOR'S MANSION AND THE RESIDENTS

Kaplaun discussed that the Governor's mansion was donated to the state to be used as a residence for the current governor. However, as Bob noted, our current governor, Tim Pawlenty, has a house south of the neighborhood, and doesn't live in the residence. This is because Tim Pawlenty's wife is a judge and has to live in the county where she works. However, the last Minnesota Governor, Jesse Ventura, did live in the mansion and the presence of family in did not go unnoticed by Kaplaun or the rest of the community.

NORTH OF MITCHELL

Many buildings in the area north of Mitchell have been devoted to low income housing. Additionally, Kaplaun stated that the neighborhood north of Mitchell does have a higher crime rate. He tells The Opinion that the City of St. Paul has been trying to solve the crime rate with more police officers, but that has proven an ineffective means for dealing with the problem. Kaplaun however has faith that the residents themselves can make a difference.

WILLIAM MITCHELL'S AFFECT ON THE COMMUNITY

Kaplaun tells us that since Mitchell came to the neighborhood in the 1970's, their presence has had a positive impact on the neighborhood. He notes however that Mitchell's parking lot may be big enough to minimize the parking problems.

We asked Kaplaun if there were any issues that the Mitchell community should address in our community. He mentioned that Mitchell could take a more active role in banning the drinking outside of bars. Kaplaun noted that outside drinking leads to an increase in vandalism in the neighborhood. Additionally, when people drink they cause property and physical damage to themselves. This forces maintenance employees from the local buildings to clean up the damage. Kaplaun also mentioned that city workers will not step in to help in clean up therefore Mitchell should step in to combat this problem.

We see this community around Mitchell daily. The more we know about its history and neighborhood concerns, the more effective role Mitchell, and its students, can play in the future.

OBAMA'S FOREIGN POLICY:

A CHANGE IN TACTICS AS OPPOSED TO IDEOLOGY

Much of the grassroots support for Barack Obama was predicated on a new foreign policy, and on the ability to restore the United States role as a respected and benevolent leader figure in the world. This proposition was flawed, largely due to the historical amnesia of much of the American electorate when it comes to understanding our history of non-benevolent intervention dating back to the 1890's. George W. Bush, with his sturdy cabal of former trotskyists turned neo-conservative advisors, certainly increased the overall complexity of adventurism. They did this by increasing the sheer troops numbers and the amount of dollars spent, which is the American imperial exception. Yet they did not create the mantle of American double standards, and nor will their ideals leave the field of interna-tional relations with their departure.

To be certain Barack Obama is more interested in how Americans are perceived. His decision to speak to Al Arabiya TV, as opposed to the American funded proxy station in Iraq was refreshing. Furthermore, his efforts at curtailing the potential provocation of the proposed missile defense shield in Czech Republic and Poland should be applauded. . I also credit him with his dispatching of an envoy for recent discussions with Syria. Also, despite Joe Biden's history of hostility towards Slavic leaders with an independent foreign policy—ala Yugoslavia in 1999, I don't believe Russia is the priority. After all NATO may need its help in Afghanistan, which is the new administration's biggest challenge.

The Afghanistan war suffers from a lack of meaning. Obama elevated Iraq War dissenting General Eric Shinseki, for his past bravery in standing up to the Bush Administration concerning the troop numbers in Iraq. It seems he is not interested in inquiring into why 17,000 new troops are needed in Afghanistan, as many Afghan leaders are saying more NATO troops are not the answer, but it is a motivator for more insurgency. The Obama administration slighted the current president Hamid Karzai, by not inviting him to the presidential inauguration. They are frustrated with him in many ways, including his administration's lack of transparency. But this is not a new gripe. Potential challengers like former warlord Agua Sherzai do not favor the United States because they are more democratic, but because they are more compliant with US interests. Obama's recent plan to negotiate with moderate Taliban seems more cynical than genuine, and this was supported by Sherzai. It is easy to see fingerprints of Obama's envoy Richard Holbrooke all over this plan, since he has a record of trying to manipulate Islamic insurgents in Bosnia—and has failed badly. Holbrooke's track record, of creating a UN-NATO dictatorship in Bosnia-Herzegovina, where unaccountable international autocrats can sack party leaders, should be a red flag rather than a credential of merit for his potential to be interested in Afghan people.

Meanwhile the rhetoric towards Pakistan is totally inconsistent. The Pakistani army, which is often slandered as being complicit en

masse with the Taliban, has taken huge losses fighting against them in the tribal areas. This hasn't stopped Obama from demanding the use of more drone attacks against Pakistani fighters. It is precisely these attacks that empower the support base of Pakistani Taliban. Here the administration seems more interested in flexing muscle than in providing a coherent policy. This is all about keeping face, and continued bombing of Pakistan would be as strategically unwise and gratuitous similar to our attacks on Cambodia during the Vietnam War.

On Iraq too, we are seeing a change of rhetoric. Barack Obama has changed the words from Iraq Residual force to Transitional force. This might sound better on paper, but it still leaves room for up to 50,000 troops to be in Iraq after his proposed 19-month deadline and also for staying on later if conditions on the ground dictate it. This is something of a truism as there will be some anti-American forces that will try to exploit our last days in Iraq. Anti-American forces are an organic force in the opposition of Iraq, and arguing that they must be totally neutralized before we leave has two negative implications. It prevents the Iraqi government from taking full responsibility because they have our presence as a crutch to lean on, and secondly it justifies paternalism on our part by pathologizing any anti-American force as being irrationally motivated.

Lastly there is the question of Iran. Our own intelligence services have concluded that Iran has not been developing a nuclear weapons program since 2003. Obama has surprisingly disavowed this intelligence in mid-February, without any actual explanation. It's timing, not long after the latest Israel-Palestinian fighting, cannot be ignored especially because Israel's military establishment is a client of the US arms industry. Where Obama and Hillary Clinton get into trouble here is if they co-mingle the interests of the United States with those of Israel. Seeing that Israel has a conservative-nationalist government, including Avigdor Lieberman who has threatened a strike on Aswan Dam in Egypt

if they get out of line, fears in Tehran are heightened. There is much room for criticizing Tehran, from their general clerical illiberalism, to their claims on Bahrain's territory, yet the idea that they want to obliterate the United States or even Israel is not rooted in reality. The rhetoric on Iran is so skewed. This is evident in the visceral animosity by some pro-Israel commentators towards Roger Cohen for his noble attempt to cast some shades of nuance and journalistic integrity on the conflict, in his recent piece covering the largely peaceful existence of Iran's own Jewish community. If Obama succumbs to the voices of ignorance that paint Ahmadinejad as a Persian version of Hitler, we are doomed to another imperial adventure in a country that is rightfully hostile to foreign interference.

Barack Obama was a welcome change from George W. Bush, however he offers only a modest paradigm shift from a general imperialist outlook. The fact that Iraq, Iran, and Pakistan are still being sold as binary morality tales between benevolent American interests and Islamic insurgencies show that what change has occurred have been a change of tactics more than a change of ideology.
